Michael Jay Sweaza, whose name is to your affiant otherwise unknown, did, unlawfully possesses approximately .5 grams of Heroin, in violation of Section 13A-12-212 of the Code of Alabama, against the peace and dignity of the State of Alabama.

Your affiant offers the following facts and information in support of his belief that probable cause exists for the issuance of an arrest warrant, to-wit:

On July 3<sup>rd</sup>, 2018 at 10:32pm, Sergeant Byron Williams responded to a suspicious person at the Decatur Morgan Hospital located at 1201 7<sup>th</sup> St SE. Upon arrival, Sergeant Williams made contact with Michael Sweaza, who witnesses identified as the suspicious person.

During the investigation, Sergeant Williams located a loaded Syringe and a small tin with a brown rock like substance identified as Heroin in Sweaza's possession.
