




COUNT 1

The Grand Jury of said county charge that, before the finding of this indictment, CRYSTAL LYNN BULLINER, whose name is otherwise unknown to the Grand Jury, did recklessly cause the death of VINCENT MITCHELL MCGOUGH by ILLEGALLY PROVIDING FENTANYL PATCHES TO HIM WHICH CAUSED HIS DEATH, in violation of Title 13A-6-3(a) (1) of the CODE OF ALABAMA,

COUNT 2

The Grand Jury of said county further charge that, before the finding of this indictment, CRYSTAL LYNN BULLINER, whose name is otherwise unknown to the Grand Jury, did commit or attempt to commit the crime of, to-wit: UNLAWFUL DISTRIBUTION OF A CONTROLLED SUBSTANCE, and, in the course of and in furtherance of the said crime that the said CRYSTAL LYNN BULLINER was committing or attempting to commit, or in immediate flight therefrom, the said CRYSTAL LYNN BULLINER, or another participant, caused the death of another person, to-wit: VINCENT MITCHELL MCGOUGH, by ILLEGALLY PROVIDING FENTANYL PATCHES TO HIM WHICH CAUSED HIS DEATH, in violation of Title 13A-6-2(a)(3) of the Code of Alabama

COUNT 3

The Grand Jury of said county further charge that, before the finding of this indictment, CRYSTAL LYNN BULLINER, whose name is otherwise unknown to the Grand Jury, did under circumstances manifesting extreme indifference to human life, she recklessly engages in conduct, to-wit: THE UNLAWFUL DISTRIBUTION OF FENTANYL PATCHES, A CONTROLLED SUBSTANCE, which creates a grave risk of death to a person other than herself, and thereby causes the death of another person, to-wit: VINCENT MITCHELL MCGOUGH in violation of Title 13A-6-2(a)(2), of the Code of Alabama,

AGAINST THE PEACE AND DIGNITY OF THE STATE OF ALABAMA.
